

**FREE ONE (1) MONTH PA BENEFIT FOR AXCESS MEMBERS AT GIANT AND TMC STORES  
(LIMITED TIME PROMOTION)**

**TERMS AND CONDITIONS**

1. These terms and conditions ("**Terms and Conditions**") replace and supersede any previously issued terms and conditions relating to the Personal Accident insurance coverage benefits ("**PA Benefit**") which customers of Giant and TMC supermarkets ("**Stores**") can be eligible for.
2. For a limited time only commencing from 25 October 2018 until 31 December 2018 and while stocks last ("**Limited Time Promotion**"), customers between the age of 18 and 75 who spend a minimum of Ringgit Malaysia Thirty (RM30.00) in one receipt at the Stores will be entitled to purchase one (1) AXCESS card there at the reduced price of Ringgit Malaysia Five (RM5.00) only and shall, subject to these Terms and Conditions and the terms of the Group Personal Accident (PA) master policy issued by AIG Malaysia Insurance Berhad ("**Master Policy**") in favour of Shieldcard Holdings Sdn Bhd ("**Shieldcard**"), be entitled, at no additional cost, to one (1) month free PA Benefit.
3. The PA Benefit shall be in accordance with the terms of the Master Policy and comprise the following:
  - A. Upon Accidental Death
    - (i) Cash pay-out of Ringgit Malaysia Ten Thousand (RM10,000.00) only with an additional pay-out of Ringgit Malaysia Ten Thousand (RM10,000.00) only for accidental death on Public Holidays declared by the Government of Malaysia; and
    - (ii) Grocery vouchers worth RM300.00 each month for a period of sixty (60) months for a total value of RM18,000.00.
  - B. Upon Permanent Disablement
    - (i) Cash pay-out of up to Ringgit Malaysia Ten Thousand (RM10,000.00); and
    - (ii) Grocery Vouchers worth RM300 each month for up to a maximum period of sixty (60) months and up to a maximum value of RM18,000.00.
  - C. Hospital Income due to an Accident

RM50.00 per day for up to 30 days so that the maximum amount that can be claimed is RM1,500.00.
4. The PA Benefit and coverage is valid for 24 hours a day and 7 days a week, worldwide.
5. For this Limited Time Promotion, upon activation of the AXCESS card, the free first (1) month PA Benefit shall be for the periods stated below:

6. AXCESS card activation can be done by visiting [www.axcess.com.my/activation](http://www.axcess.com.my/activation) and providing the details required for registration as an AXCESS member.
7. After the end of the initial free first month PA Benefit, AXCESS members can continuously be eligible for the PA Benefit by spending a minimum of RM200.00 ("**Minimum Spending**") at the Stores during the spending periods which begin on the 16<sup>th</sup> of the month until the 15<sup>th</sup> of the following month ("**Spending Periods**"). 8. Bill payments and purchases of tobacco, cigarettes, top-ups or e-money and gift vouchers shall be excluded in determining the Minimum Spending and customer's eligibility to purchase the AXCESS card at RM5.00 as set out in Item 2 above.
9. Only AXCESS members who have activated their card are eligible to receive the PA Benefit.
10. Upon achieving the Minimum Spending, an e-mail/SMS shall be sent to the AXCESS member notifying him/her of the same and the period of the PA Benefit the member is entitled to.
11. Each AXCESS member is only eligible for One (1) free PA Benefit under this promotion.
12. The first RM200.00 spent in a Spending Period shall not be awarded any AXCESSpoints. Only amounts spent above the Minimum Spending shall be eligible to receive AXCESSpoints according to the prevailing rate offered by the respective Stores.
13. Customers who do not activate their AXCESS Card may not earn any AXCESSpoints for purchases made.
